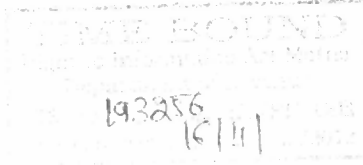

to this point may be treated as 'Nil'.


Point (ii)- Gr. A. and Gr.B officers who have been given sensitive charge despite
