TENDER NOTICE

Sealed Tenders are invited from the reputed bottle seal Manufacturers having rendered services to Central Excise organization, with good track record and experience in manufacture and supply of One Time Bottle Seals, for the Commissionerate of Central Excise, Belapur, having its office at 1st Floor, C.G.O Complex, CBD Belapur, Navi Mumbai - 400 614. The One Time Bottle Seals shall have the following specifications

SPECIFICATIONS:

Tamper Proof One Time Container/Bolt/Roto Block /Blocker Bottle Seals made up of Polypropylene and ABS Plastic with a provision for Anti Spin mechanism. (Separate quote may be furnished for Polypropylene and ABS Plastic makes).

1. One Time Keyless bottle seal lock should be of standard make, suitable for sealing ISO containers. The preferred dimensions may be "10 mm thick ABS/Polypropylene plastic coated metallic rod and the body is coated ABS/PP Plastic and is engraved with name and serial number.
2. Seal locks shall conform to the standard breaking strength. Normally it is 1-1/2 tonne.
3. The plastic coating should be of high quality ABS /PP Plastic. Separate quotes for ABS and PP material shall have to provided.
4. The seal should be made of high Carbon steel of good quality.
5. The seal should bear office embossing/engraving name viz., "Central Excise Belapur", & National Emblem (Ashok Sthambh) embossing on the Bolt Head.
6. The seals shall have laser engraved legible running serial number & marking as "Central Excise, Belapur".
7. The seals shall have Anti Spin & or Blocker mechanism.

Separate quotes are required to be furnished for supply of ABS Plastic and Polypropylene Plastic make Bottle Seals.

All tenders are required to be addressed to the Additional Commissioner (P&V), Central Excise, Belapur Commissionerate, 1st Floor, CGO Complex, CBD Belapur, Navi Mumbai - 400 617. It is required to clearly mention on top of the cover as "**Quotation for Bottle Seals**".

The sealed tenders must reach in the Commissioner, Central Excise, Belapur Commissionerate, 1st Floor, CGO Complex, CBD Belapur, Navi Mumbai - 400 617 on or before **26th December 2016 up to 17:00 Hrs.** Tenders will be **opened on 27th December 2016 at 11:30 Hrs.**

ELIGIBILITY CRITERIA

Party who wishes to participate should qualify the following eligibility parameters for submitting the tender.

1. Tenderer must be a ISO Certified firm having their own manufacturing facility and who are in the field of manufacture and supply of One Time Bottle seals for more than 15 years.
2. Tenderer should have inbuilt manufacturing facility and should have manufactured and supplied the bottle seals to Shipping Companies & Central Government Departments during the last 10 years (Proof must be furnished).
3. Tenderer must have a minimum average financial turnover of Rs.300 lakhs during each of the last three financial years. A Certificate duly signed by their Chartered Accountant or IT returns shall have to be enclosed with the Tender.
4. Registered with MVAT Authorities (proof must be furnished).

TERMS & CONDITIONS

1. The Tender should be addressed to the Commissioner, Central Excise, Belapur, 1st Floor, CGO Complex, CBD Belapur, Navi Mumbai 400 614.
2. The sealed tenders must reach in the Office of Commissioner, Central Excise, Belapur Commissionerate, 1st Floor, CGO Complex, CBD Belapur, Navi Mumbai - 400 617 on or **before 26th December 2016 up to 17:00 Hrs.** Tenders will be opened on **27th December 2016 at 11:30 Hrs.**
3. The tendered should enclose one sample of Bottle Seal along with the tender having technical characteristic/specifications mentioned above. The department reserves the right to reject the bid if the samples do not meet the technical characteristic as specified.
4. The authority reserves the right to cancel or postpone or accept/reject any tender without assigning any reason, thereof. The authority's decision will be final.
5. The tender should be signed and stamped by the authorized person of the Tendering firm/company.
6. Incomplete tenders are liable to be rejected.
7. The tenderers shall provide information in respect PAN.
8. The validity of quote price should be for at least ONE year from the date of opening of the tender.
9. The tender price for ABS Plastic and Polypropylene makes (separate quote must be submitted) should be inclusive of all taxes, packing & forwarding, transportation freight, insurance loading & unloading charges. The delivery should be made at CGO complex, CBD Belapur.
10. The Rate of the quote must be shown in figures as well as words. Any alterations in rate should be signed in the ink.
11. Defective bottle seals, if found at the time of use, the said bottle seals shall be replaced free of cost by the supplier. If it is found that there are repeated complaints of defective supply of Bottle Seals, the department reserves the right to cancel the order anytime during the agreement period.
12. Catalogues/Full particulars of the Bottle Seal should BE FURNISHED.
13. Quotations/tenders received later i.e., after due date and time will be summarily rejected.
14. Payment against bill/Invoice shall be realized only after satisfactory compliance.
15. The vendor should indicate the guarantee of quality in the quotation.
16. The vendor should check the seals during packing and ensure that there are no missing, defective, duplicate number Seals and also affix a sticker on each box specifying the above fact.
17. Quotation/Tender not fulfilling above terms & conditions shall not be considered and in case of any variance at any point or between amount quoted in figures and words, the quotations will be summarily rejected.
18. The authority reserves the right to cancel or postpone the tender without assigning any reason thereof. The authority's decision will be final.
19. While the vendor and Government shall make every effort to resolve disputes amicably by direct informal discussions, even then, if there is any disagreement or dispute arises in connection with the tender/contract, it shall be settled by the Court of Law within the jurisdiction of Navi Mumbai/Mumbai. The resultant contract will be interpreted under Indian Laws.
20. The tenderer must start supplies One Time Bottles seals with above specifications within a week from the date of acceptance of the Order
21. Tenders submitted by the tenderers will be entertained only after their fulfilling the criteria as mentioned above.
22. Tender once submitted shall not be withdrawn by the tenderer.
